5 YEARS SPA SHELL

2 YEARS ELECTRICAL COMPONENTS

Subject to the limitations and exclusions listed herein, Sundance® Spas warrants the factory installed electrical components to be free from defects in material or workmanship, for a period of two (2) year from the original date of purchase or two (2) years plus six (6) months from date of manufacture, whichever period elapses first.

2 YEARS PLUMBING

Subject to the limitations and exclusions listed herein, Sundance® Spas warrants the factory installed plumbing components including the hoses, pipes, jets, air controls and unions, against leaking due to defects in workmanship or materials for a period of two (2) year from the original date of purchase or two (2) years plus six (6) months from date of manufacture, whichever period elapses first.

2 YEARS INSULATING COVER

Subject to the limitations and exclusions listed herein, Sundance® Spas warrants the factory supplied insulating cover to be free from defects in material or workmanship, for a period of two (2) year from the original date of purchase or two (2) years plus six (6) months from date of manufacture, whichever period elapses first.

2 YEARS LABOR

Subject to the limitations and exclusions listed herein, Sundance® Spas will reimburse labor to perform warranty service, at Sundance® Spas established rates for work performed, for a period of two (2) year from the original date of purchase.

EXTENT OF WARRANTY

This limited warranty extends solely to the original purchaser of a Sundance® Spas branded spa, when purchased and originally installed. This warranty terminates upon any transfer of ownership.

PARTS & ACCESSORIES

Genuine Sundance® Spas Parts & Accessories - This Limited Warranty is void if Sundance Spas, Inc. ("Manufacturer") or its designated representative determines that the spa has been subjected to damage or failure due to installation of aftermarket parts that are not Genuine Sundance® Spas branded Parts & Accessories. This disclaimer includes, but is not limited to filters, ozone systems, repair parts and other accessories. Genuine Sundance® Spas brand Parts & Accessories are built to our highest standards of quality, durability and performance, and they are designed to work with your spa to ensure optimal performance and function.

PERFORMANCE

To make a claim under this warranty, contact your Sundance® Spas dealer. You must give your Sundance® Spas.dealer written notice of any warranty claim, along with a copy of your original purchase receipt indicating the date of the purchase, within ten (10) days of the time you discover the claim. Sundance® Spas reserves the right to inspect the malfunction or defect on location. Sundance® Spas reserves the right to examine photographs prior to repair or replacement. In the case of a shell repair or replacement, Sundance® Spas will, at its option, repair or replace the shell portion of the spa, at the factory, at the spa installation site or at a local authorized repair station. Any warranted labor reimbursement will be at Sundance® Spas established rates for work performed. Trip charges, if applicable, are not covered under the labor warranty and are the responsibility of the purchaser. .

LIMITATIONS AND EXCLUSIONS

Labor reimbursement does not include routine maintenance such as tightening jets, lubricating O-rings, changing/cleaning filters, chemical checks and adjustments, or anything else that would be considered routine maintenance. Filters, LED lights, light bulbs, fuses and pump seals are considered wearable parts and are excluded from the warranty. This warranty does not cover any part of the umbrella (if equipped) after initial installation. This warranty covers only the spa unit and equipment, or components used in its manufacture, for the periods stated.
